Safety Instructions / Handling of Swollen Lithium-Ion Batteries

Safety Measures

- » Do not use the device
- » Do not charge the device
- » Avoid mechanical stress (e.g., pressure or shocks) Explosion hazard!

Storage

- » Store in a cool and dry place
- » Use fireproof packaging, such as a specialized box or metal container

Disposal

Opening the housing can damage the battery and create an immediate fire or explosion hazard. Any manipulation increases the risk of a short circuit or thermal runaway.

Warning: Even a single one of the following signs indicates acute fire or explosion risk and requires immediate response:

Critical warning signs:

- » Visible swelling or deformation of the battery regardless of whether minor or severe.
- » Smoke emission or unusual smell from the battery.
- » Important: Even one of these symptoms is enough to classify the battery as dangerous.

Shipping prohibition:

Swollen and/or smoking lithium-ion batteries are strictly prohibited from shipping via mail, courier, or any transport service due to fire and explosion hazards.

What is allowed?

Lithium-ion batteries may only be disposed of or shipped via standard procedures if all of the following conditions are met:

- » They are externally undamaged.
- » They show no signs of thermal instability (e.g., swelling, cracks, excessive heat).
- » There is no smoke or unusual odor.
- » The defect is typical, e.g., capacity loss or charging failure.

In such cases, standard hazardous materials and disposal regulations apply.

Please note: Lithium-ion batteries are subject to special packaging and labeling requirements.

Always confirm with the shipping provider in advance whether and how the shipment is permissible.
